Date: September 17-19, 2021, Friday, Saturday and Sunday

Location: The Ken Smith Bullseye Pistol Range, River Bend Gun Club, 988 River Bend Gun Club Road, Dawsonville, GA 30534 (map available at www.rbgc.org). *GPS Coordinates: N34° 20.363' W084° 15.102'*

Eligibility: Open to any individual. There will be team matches in .22, centerfire and .45.

The Georgia State Champion must be a resident of the state of Georgia and must be a member of the Georgia Sport Shooting Association (GSSA). All Georgia residents participating in the State Championship must be members in good standing of the GSSA. GSSA membership is \$15 per year. Applications will be available at the match. Easiest way to join or renew is at www.georgiasportshootingassociation.org.

CMP Competition Tracker Number: In order to enter scores of competitors in the computer classification system, all competitors who have CMP CT numbers must provide such number on their entry form and each scorecard. If you do not yet have a CMP CT number, you will receive one from CMP. Leave that space blank for now.

Rules: Current CMP Pistol Competition Rules (24th Edition—2020) will govern for the all matches held in conjunction with the State Championship. CMP affidavits will be processed during check in.

Awards: Trophies and cash awards will be issued to the Match Winner, Second Overall, Third Overall and State Champion (high Georgia resident), as well as the high scorer in each classification. An award for second place in each class will be made, provided there are at least five entries in that class. Points and medals for the CMP Service Pistol Match and Distinguished .22 Match are provided by the Civilian Marksmanship Program. All other awards are provided by Georgia Sport Shooting Association and River Bend Gun Club.

Shooters may enter the CMP Match Revolver match even if they do not enter the State Championship 2700 match.

A large prize table will be stocked with a wide assortment of valuable gifts provided by local businesses and supporters of River Bend's Bullseye program.

Five shooters will be awarded \$100 each in a random drawing.

Classification: The CMP classification system will be used in all matches. Individuals who have not been classified by CMP will use an established NRA classification.

Categories: All shooters will compete in an Open Category.

Classes: A minimum of 4 competitors will constitute a class. If less than 4 competitors, those competitors will compete in the next higher class.

Challenges: A challenge fee of \$2 will be charged for each challenge made. See NRA rule 16 for correct procedure.

Squadding: Squadding will be completed by match time on the day of the match. Match director will have final authority on squadding and start times.

Time of Firing: Firing will commence at 10:00 AM each day.

Entries: Entries in individual events will be made by using the enclosed Statistical Office Record Form accompanied by check or money order. Checks should be made payable to **David W Donley**. Be sure to indicate your correct CMP classification and CMP CT number. *Also, please indicate in which disciplines you are Distinguished.* Confirmation will be made upon request by email. Entries Close: Individual entries must be received no later than 5:00p.m. September 10, 2021.

Entries Limited: Plans are for one relay of 48 competitors. If the number of entries warrants, additional relays may be added. Preference will be given to competitors who fire the full schedule.

Post Entries: Post entries will be accepted up to the stated limit of the range, provided such entries will not require special relays.
